

Liability Form - Road America- June 24-27, 2021

All Participants Please Read:

Note: The Northwoods Shelby Club and Road America reserve the right to accept or reject entries on an individual basis. Receipt of entry or event advertisement DOES NOT constitute acceptance. High Speed Touring is an inherently dangerous sport. Each entrant assumes that risk when he or she participates in an event. The risk of serious injury or death cannot be eliminated and, in fact, will always be present at a high level. Participants are required to advise their spouses and next of kin, if any, of this fact. The Northwoods Shelby Club and Road America are not responsible for the adequacy of an entrant's car, equipment, driving capabilities, or activity.

Note: Any physical damage done to the track or track facilities are solely the financial responsibility of the party deemed by Road America officials to have caused the damage. Northwoods Shelby Club is not financially liable for any damage to the track or track facilities caused by any participant. (i.e. if you hit a guardrail, jersey barrier, tire wall, use of oil dry, etc. you will be financially responsible for the damages)

Note: In submitting this application, the applicant: 1) acknowledges familiarity with the bylaws of the Northwoods Shelby Club 2) agrees to abide by Northwoods Shelby Club rules which pertain to the running of this event, the specific regulations of Road America, and any special rules and regulations which are established to cover the running of this event and agreeing without reservation to the consequences from the Northwoods Shelby Club resulting for violation of aforesaid, and 3) renounces the right to have any recourse to any arbiter or tribunal not provided for in the bylaws, and specifically covenants not to file suit, in law or equity for any review of any act or decision of the officers of the Northwoods Shelby Club and Road America. Northwoods Shelby Club and Road America reserve the right to refuse the entry of any application, or to reclassify entrants, as they deem appropriate.

Note: The Northwoods Shelby Club considers participants to be anyone present at the event. This includes, but is not limited to, car owners, drivers, passengers, and spectators.

Note: This form is required for pre-registration at all events.

Helmet Liability Waiver: I/We acknowledge that the inspection of my helmet by volunteers assisting at the NWSC HPDE is for the sole purpose of determining whether my helmet has met the minimum standards of the Snell Memorial Foundation and that it appears from a visual inspection to contain the appropriate Snell rating sticker and to be capable of meeting those standards at the present time. I acknowledge that the NWSC is making no guarantee of fitness for use in "passing" my helmet, and that I am relying solely on my own judgment in using the helmet in an NWSC event. I release, acquit, and forever discharge the NWSC its officers, members, employees, lessors, associates, successors, or assigns, from any and all liability, claims, demands or causes which may arise from my wearing of the inspected helmet, from my attendance at an NWSC event, or from any injury sustained by me, whether or not due to negligence. I represent that I am over the age of 18 and that I understand that I am participating in a dangerous event and that my helmet has not previously been worn in a collision or struck by a hard object.

Publicity Release: As a condition of acceptance participants agree to permit Northwoods Shelby Club and Road America the use of their voice and/or likeness for news, publicity and future use including radio, TV and printed media. He/She/They further stipulate that no prior agreement with sponsor or other persons are in conflict with this agreement.
